SDUHSD Course Selection Guidelines

- Students must take a minimum of 3 classes per day. Students are not required to take 4 classes per day, and have the option to select an **unscheduled period**.* If an unscheduled period is selected, no class or teacher will be assigned and no attendance will be taken.
- Courses may be cancelled due to insufficient enrollment or staffing restrictions.
- 12th grade students may be given preference in elective classes and courses required for graduation.
- For any **application or audition-only course**, please select the course and visit the [Audition/Application Course Profile](#) page to follow the steps to apply or audition. **Remember to select alternates for these classes in case you are not selected.**
- 10-12th grade student-athletes who require PE credits to graduate may be eligible to use their school-sponsored CIF athletic program to earn 5 credits per season. To be eligible for these credits, students must have passed the California Physical Fitness Test, submit an application for *PE Credit-Athletics* to the athletics department by their posted deadline, and complete the full CIF season.
- Eligible students may apply for Independent Study Physical Education* (ISPE) at sduhsd.net. **All students who apply for ISPE must have completed the required Health curriculum and Grade 10-12 students must have passed the CA fitness test before they will be approved for ISPE.** If a student is approved, the student will not be assigned to a class or teacher that period and no attendance will be taken.
- 30 credits maximum from approved off campus coursework can be applied toward graduation requirements and coursework will be added to a student's transcript **only** if the course is pre-approved before the student enrolls in the course.
- Students will be able to view their 2019-2020 class schedules in the Aeries Portal in August. Required schedule changes will be made for students who failed a course or completed a pre-approved off-campus summer class during the Raven Readiness period.
- SDUHSD Board Policy sets a **two-week limit** at the beginning of each term to drop a class without it reflecting on the transcript.

I understand:

- Students are selecting classes only for the entire year, not teachers, terms or periods.
- No schedule changes will be made to accommodate any off-campus, extra-curricular, jobs or athletic activities.
- The only way to indicate that a student is requesting **not** to have a class during a specific period or term is to request an unscheduled period.
- No schedule changes will be made to change periods or terms for already scheduled classes.
- No elective changes will be made after the start of the school year. This includes AP to AP class changes. See add/drop form for more info
