# **Canyon Crest Academy – Discipline Policy**

All CCA students and parents are required to sign a Discipline Policy Notification Form that is submitted during Readiness Days and certifies that students are familiar with key school rules and are aware of the discipline policy as a whole.

#### General School Rules

- Students will follow the SDUHSD Academic Honesty Policy. (See below for more details)
- Students will treat peers and all school staff with respect.
- Students will not use profanity and/or commit vulgar or obscene acts or make inappropriate displays of affection or be in possession of obscene, or vulgar material.
- Willful defiance of authority or disruption of academic, athletic, or activity programs is not acceptable.
- Students will not harass or intimidate students or staff.
- Students will not engage in conduct constituting sexual harassment and or sexual assault.
- Students will not fight.
- Students will not possess, sell, or furnish controlled substances (drugs or alcohol).
- Students will not possess or be under the influence of alcohol, drugs, or paraphernalia at school or at school events.
- Students will not steal, deface, or vandalize school property.
- CCA is a closed campus for Freshman and Sophomores. Only juniors and seniors are allowed to leave campus for lunch.
- No guest passes for students not enrolled in CCA allowed during school hours.
- Mobile devices such as Smart Phones, Laptops, Chromebooks, Tablets and other similar devices are allowed at school and may be used to support learning. The use of this technology is at the discretion and supervision of each classroom teacher.
- Skateboarding on school grounds is prohibited.
  - o Consequences for Breaking School Rules (one or more of the following may occur)
    - Warning, Parent contact/conference, Detention, Saturday School, School/Class Suspension, Alternative School Placement, Expulsion

#### Dress Code

 Students will wear shoes at all times. Prescribed clothing must be worn for Physical Education. No bare midriff tops, bathing suits, or other revealing clothing that might interfere with the educational process. No clothing or jewelry displaying alcohol, sex, controlled substances or the promotion of gangs or violence. No chains or spiked apparel.

### Consequences for Dress Code Violation

 Students dressed inappropriately are subject to school discipline procedures as listed under "consequences for breaking school rules". In addition the student may be sent to Assistant Principal's office and /or sent home to change.

# SDUHSD Academic Honesty Policy

- Honest behavior is an expectation for all students in the San Dieguito Union High School District. The purpose of this regulation is to create and maintain an ethical academic atmosphere. Specific types of academic dishonesty, which will not be tolerated, are defined below:
  - Cheating on Tests Any intentional giving of or use of external assistance relating to an examination, test, or quiz without express permission of the teacher.
  - Fabrication any intentional falsification or invention of data, citation, or other authority in an academic exercise.
  - Unauthorized Collaboration While collaboration is often encouraged, unauthorized collaboration is not permitted.

- Plagiarism Any intentional representation of another's ideas, words, or works as one's own. Plagiarism includes the misuse of published material, electronic material, and/or the work of other students. The original writer who intentionally shares his/her paper for another to copy, without the permission of the teacher, is also engaged in plagiarism.
- Alteration of Materials Any intentional and unauthorized alteration of student, teacher, or library materials.
- Forgery any unauthorized signing of another person's name to school related documents.
- Theft any theft of materials.
- Transfer of Unauthorized Materials any giving or selling of unauthorized materials.

# Consequences for Academic Dishonesty

- Any alleged violation of this policy will be investigated thoroughly and appropriate disciplinary measures will be taken consistent with Board policy. Depending on the severity of the offense one or more of the following consequences may occur:
  - Referral to the assistant principal and the parent/guardian will be contacted.
  - Loss of all credit for the assignment or test with no makeup permitted.
  - Placement on probation with a contract (in the class of the infraction) for the remainder of that class.
  - Violation on a school administered national or state examination will result in a district code of conduct violation.
  - Dropped from the class with no credit.
  - Suspension from school.
  - Removal from all elected or appointed leadership positions for the remainder of the school year.

# Saturday School

- Students are scheduled for a specific date and receive notification of where to report.
- Students that have been assigned Saturday School must be on time and bring schoolwork or reading material. "No Show" students will receive further disciplinary action

#### Nondiscrimination

 It shall be the policy of the San Dieguito Union High School District to prohibit discrimination on the basis of sex, disability, race, color, national origin, religious creed, age, marital status, or sexual orientation in the educational programs and activities which it operates. A

#### Harassment and Hate Violence

- Harassment is defined as threats or intimidation directed against a student or group of students that is sufficiently severe or pervasive that it materially disrupts class work, creates disorder, and invades the rights of that student or group of students.
- o Hate violence is defined as any act punishable under California Statues that interferes with the exercise of an individual's civil rights, defacing or damaging personal property or felonies against persons because of the victim's race, color, religion, nationality, or ancestry. (Penal Code Sections 442.6, 442.7, and 442.7.75.)

 Students are subject to suspension and/or expulsion for harassment and/or hate violence when other means of correction have failed to bring about proper conduct or if the student's presence causes a continuing danger to physical safety or threaten to disrupt the educational process.

#### Sexual Harassment

- Definition: "Sexual harassment" means unwelcome sexual advances, requests for sexual favors, and any other verbal, visual, or physical conduct of a sexual nature made by any person from or in the work or educational setting under any of the following conditions:
  - Submission to the conduct is explicitly or implicitly made a term or a condition of an individual's employment, academic status, or progress.
  - Submission to, or rejection of, the conduct by the individual is used as the basis of employment or academic decisions affecting the individual.
  - The conduct has the purpose or effect of having a negative impact upon the individual's work or academic performance, or of creating an intimidating, hostile, or offensive work or educational environment
  - Submission to, or rejection of, the conduct by the individual is used as the basis for any decision affecting the individual regarding the benefits and services, honors, programs, or activities available at or through the educational institution.
  - As it relates to students, subjects any pupil to discrimination on the basis of sex, including sexual harassment, in any district program or activity.
  - Other types of conduct which are prohibited in the district and which may constitute sexual harassment include:
    - Unwelcome leering, sexual flirtations or propositions.
    - Unwelcome sexual slurs, epithets, threats, verbal abuse, derogatory comments or sexually degrading descriptions.
    - Graphic verbal comments about an individual's body or overly personal conversation.
    - Sexual jokes, stories, drawings, pictures or gestures.
    - Spreading sexual rumors.
    - Teasing or sexual remarks about students enrolled in a predominately single-sex class.
    - Touching an individual's body or clothes in a sexual way.
    - Purposefully limiting a student's access to educational tools.
    - Cornering or blocking of normal movements.
    - Displaying sexually suggestive objects in the educational environment.
    - Any act of retaliation against an individual who reports a violation of the district's sexual harassment policy or who participates in the investigation of a sexual harassment complaint.
- School consequences for any instances of sexual harassment will be strictly imposed.

#### Tobacco Free Facility

o In the best interest of students, employees and the general public, the Board of Education prohibits the use of tobacco products (this includes any type of e-cigarette) at all times on district property and in district vehicles. This prohibition applies to all employees, students, visitors and other persons at any school or school sponsored activities or athletic event. It applies to any meeting on any property owned, leased or rented by or from the district. Tobacco products are prohibited from use or possession by students on campus or within 1,000 feet of campus boundaries.

#### Safe School

Students and staff members are entitled under the California State Constitution to attend schools that are safe, secure, and peaceful. The presence of weapons or replicas contribute to a climate of fear and disrupts the learning environment of the school Replicas of weapons whether they be toy firearms, theatrical props, cap guns, starter pistols or replicas of other deadly weapons, have no place in the school environment.

# Weapons

- Students utilizing any dangerous or deadly weapon (including replicas) in a threatening manner or to incite fear, inflict injury, or disrupt the educational process are subject to suspension/expulsion.
- Any SDUHSD employee or district contracted transportation service representative may remove from the possession of any student any firearm, knife (including Swiss army, pocket, etc.), explosive or other dangerous objects, while the student is on school premises or engaged in any school sponsored activity or going to or returning from school or otherwise under the authority of the school.
- This act shall be reported to the principal/designee. The student will surrender all dangerous objects or be subject to disciplinary action for such refusal. Parents and appropriate law enforcement officials shall be notified by the principal/designee of the taking of weapons and the disciplinary action followed. Students are subject to suspension or expulsion for possessing illegal weapons upon a first offense. Illegal weapons will be turned over to the police department as evidence. Other items may be returned to parents and/or guardians.

#### Search and Seizure

 To maintain order on school premises, it may be necessary at times to conduct searches of vehicles or require students to submit to searches for weapons, drugs, or contraband.

# Student Parking

Student parking is available in the student parking lot and designated areas in the staff lot and all students must have valid parking permit to utilize the lot. Parking permits may be acquired through the ASB office. Per SDUHSD policy, students must attend a Start Smart class before they are eligible to purchase a permit. Cars parked in staff or visitor areas, or without a permit may receive a San Diego police department parking ticket.

Students under age 18 **must** be accompanied by a parent/guardian or other person specified by law when transporting passengers under 20 years of age, stany time for the **first twelve months** of obtaining a drivers license.
