New Business

Site plan review and revision

Lisha Brunache shared new CAASPP data, AP exam scores, D/F students data and suspension rate data. New data was updated. Some "summary of Progress" information was changed on past goals.

Data from the healthy kid survey was added to past goal #2 (safety and connectedness).

Past Goal #3 (Instructional Goal) no changes added. A line was added regarding science teacher training for Next Generation Science Standards.

Motion to approve changes by Jill Duoto

Seconded by Sami Rana

Approved by Unanimous Vote

New goals reflect 1) balanced student achievement and implement interventions.

SSC considered adjusting Expected Measurable Outcomes in light of current data. Regarding goal #1, Jill Duoto suggested a different metric for Sped population because the group is statistically so small and variable (only 11th graders each year, only those that take the test). Lisha shared that we would not be able to use CAASPP data. Ying Yang suggested D/F grades. Something that includes all, 9-12, not just 11th. Perhaps focusing not on meeting or not meeting but trying to improve average numerical score. Potentially C or above in A-G

classes to show college readiness? For CAASPP ELA and CAASPP Math, our current goals are lower than where we scored. Jill Duoto questioned whether targeted improvement is the top priority here. Jessica Adams suggested rounding out numbers. Uday inquired about what happens if goals are not met. General ed. Support classes were initiated in response to not meeting goals in prior years. Ying Yang shared that maybe we want to keep academic metrics in goal #1 realistic and set more stringent goals in goal #2.

Regarding goal #2, Lisha shared that the data is less clear, and called for thoughts on collecting better and more data to inform expected measurable outcomes. Ying Yang suggested looking at visits to counselors or school psychologist, though Jill Duoto and Dustin Lackey added that we are actually encouraging students to visit. Questions were raised about what “extracurricular” participation rate means and what kinds of data we can generate. Jill Duoto and Lisha Brunache expressed interest in getting a copy of the healthy kids survey so we can see what questions are asked regarding social-emotional health. Conversation about the efficacy of the Social-Emotional Learning programming. Parent workshop, outreach, and feedback data could be collected.

Regarding goal #3, time restraints necessitated moving on.

WASC Process includes focus groups, home groups, and SSC’s role in the WASC report, which will be covered more in the next SSC meeting.
